The information can be confusing, and in some cases seems contradictory. However, it is required.

A few highlights related to the most commonly asked questions:

Yes, the tax rate is lower this year, but overall the city will collect more taxes.

Property Valuations have been raised, exemptions have changed, and new properties have been built.

To understand your personal tax situation, start at the Truth In Taxation web site.

A link is provided on the Enchanted Oaks Tax & Budget page.

It all boils down to the Tax Rate which is adopted, your property valuation, and your exemptions. City taxes are a relatively small piece of your overall taxes.

Compared to last year, EO will collect 8% more in tax revenue from existing properties Compared to last year, EO will also collect revenue from new property. In total EO will collect 9% more in tax revenue compared to last year.

The proposed tax rate is the maximum that can be adopted this year without Voters being able to request an election. This is confusing because the required postings/notification show a smaller rate for that threshold, which is the Voter Approval Rate (VAR). Basically there are 2 VARs - one calculated with 3.5% growth and the other calculated at 8% growth. Due to our population and the dollar amount collected, EO VAR can be calculated at 8%, but the forms & required notices show the 3.5% number.
